## Dear Resident/Neighbour

Charles Edward Limited are pleased to announce that we have been awarded the build contract to construct 35 new social rented homes, in an 11-storey building, with associated landscaping, at 52-54 New Cross Road. This project forms part of Lewisham Council's Building for Lewisham programme, which is delivering new social homes for local families on the housing waiting list to help tackle the housing crisis. We will be writing to residents on a monthly basis to update you on our site activities and progress in the period.

## Current anticipated main milestones for the project are as follows:

- Commencement of construction March 2024
- Completion 2026
