**Redevelopment of 312 – 320 Earlsfield Road**

Dear Resident/Neighbour

Charles Edward Limited are pleased to announce that we have been awarded the build contract to construct 7 new social rented homes, in a 4-storey building, with associated landscaping, at 312 – 320 Earlsfield Road. This project forms part of Wandsworth Council's Building for Wandsworth programme, which is delivering new social homes for local families on the housing waiting list to help tackle the housing crisis. We will be writing to residents to update you on our site activities and progress during the works.

**Current anticipated main milestones for the project are as follows:**

- Initial Site Investigations - Progressing
- Commencement of construction – March 2025
- Completion – Autumn 2026

## Next steps:

- We are at the moment conducting various site investigations and making arrangements for new drainage connections and incoming Electric and Water supplies.
